The Intake Counselor works full-time in a person-centered and team oriented setting to complete a detailed, comprehensive ASAM Continuum intake assessment and individualized treatment plan for all clients entering the Residential Treatment Program and other clinical programs as needed; meets the expected timeframe of completion for documentation according to insurance requirements; and coordinates within a multidisciplinary team to ensure clients are successfully oriented to the treatment program--ethically sound supervision is provided.

Responsibilities:

- Complete the intake process and prepare clients for the program.
- Screen program applicants to determine their appropriateness for the program.
- Fill out all related intake documents fully and appropriately.
- Complete the ASAM Continuum and initial individualized treatment plan.
- Make referrals to Case Manager to assist clients with emergency needs including ID, clothing, and emergency physical or mental health issues.
- Assign clients to counselors based on best fit and counselor caseload.
- Maintain consistency with documented dates for health.
- Drive clients to and from assigned destinations when needed.
- Maintain accurate, updated records in client's files.
- Conduct individual sessions with clients on a needed basis.
- Demonstrate professionalism and loyalty to the staff, agency, clients, and community.
- Follow approved policies and procedures of the agency to ensure that clients' recipient and confidentiality rights are not violated.
- Assist with groups whenever necessary.
- Participate in regular in-service training and attend workshops, seminars, as required by management.
- Other duties as assigned by the Clinical Director.
- Ability to lift 15-20 lbs.
- Ability to sit at a desk for up to 8 hours while working on the computer.

Qualifications:

- Minimum of bachelor's degree required and LBSW or LLBSW, LLMSW, LMSW, LLPC, LPC)
- Possess a minimum of a MCBAP Development Plan but a MCBAP CADC certification is preferred.
- Minimum of one year's sobriety (if recovering).



- Training and experience in alcoholism treatment and 12-Step meetings desirable.
- Ability to meet the physical, mental, and visual standards of the job.
- Ability and willingness to work in a manner which will not needlessly endanger the safety of oneself, other people, and equipment.
- Ability to establish and maintain harmonious working relationships with fellow workers, clients, and the general public.

Physical Requirements:

- Prolonged periods of sitting at a desk and working on a computer.
- Must be able to lift up to 15- 20 pounds at times.

ADDITIONAL ELIGIBILITY REQUIREMENTS

- Covid-19 vaccination per agency policy requirements
- Possess a valid First Aid/CPR certification.
- Provide education transcript.
